Booth Location: Location of exhibit space is determined at the discretion of NMCS and the host venue. Booth assignments will be made in early December 2025 giving priority to sponsors, based upon sponsorship level, followed by exhibitors based on the order signed agreements were received. NMCS reserves the right to make and/or change table locations at any time as they deem necessary. NMCS shall have the full discretion and authority in the placing, arrangement and appearance of all items to be displayed within the exhibit hall by exhibitors and reserves the right to make allowances to table construction guidelines.

Exhibit Set-up and Tear Down: Move-in is scheduled for Wednesday, January 28th 2:30- 4:30 p.m.; with move out starting at 3:45 p.m. on Friday, January 30th. Exhibitors may not setup, break down or move out displays outside these designated times.

NMCS reserves the right to refuse any sponsor/exhibitor that conflicts with NMCS policies or applicable law. Fees collected prior to such refusal shall be returned to the applicant within 45 days.

Social functions: Any functions hosted by sponsors/exhibitors must be scheduled at a time or place where they do not conflict with official NMCS activities. No exhibitor or sponsor shall contract with the venue for any signage, promotional material, room drop, event, display, or communication without the specific written permission of NMCS.

Limitation of Liability: By signing this contract, the sponsor/exhibitor agrees to indemnify and hold harmless NMCS from and against any and all claims or damages of any kind, including attorney's fees, arising from or relating to your sponsorship or this contract, and including but not limited to any claims that your artwork, logos or other materials infringe any copyright or other intellectual property rights of any third party. Sponsor also agrees that NMCS will not be held responsible for any loss, including theft, damage, or destruction of goods, or for any injury to the sponsor or its employees, while participating at any NMCS event while the event is in process, being set up, or being taken down. Sponsor agrees to indemnify and hold harmless NMCS and its officers, directors, employees, and agents from and against any and all claims of any person arising out of acts, omissions, or negligence of the sponsor, its agents, or employees.

Cancellations: All sponsor/exhibitor cancellations must be submitted in writing. Cancellations received by NMCS after Monday, November 24, 2025 will be assessed a fee of 50 percent of the total cost. No refunds will be given on cancellations received after this date. Notwithstanding any provisions to the contrary herein contained, NMCS shall not be liable for any delay or inability to perform any obligation under this agreement resulting from governmental emergency orders, judicial or governmental action, sabotage, riots, vandalism, labor strikes, or disputes, acts of God, fires, electrical failure, major computer hardware or software failures, acts of third parties, or any other cause, if such delay or inability to perform is beyond its reasonable control.

Conduct of Sponsors/Exhibitors: The purpose of the NMCS is to provide continuing education and networking opportunities.
